

Since its founding, The Posse Foundation has experienced incredible growth and a steady broadening of its national footprint. What started in 1989 as an initiative to send five public high school students from New York City to attend Vanderbilt University in Nashville, Tennessee, has become a national movement that serves thousands of remarkable young leaders from all across the country each year. Today, Posse boasts partnerships with 38 top colleges and universities, sites in seven of the country's largest cities, more than 3,000 selected Scholars and over 1,200 Alumni.



This year's annual report celebrates Posse's 20th anniversary. But the journey is far from over. By the year 2020, Posse will operate sites in 10 cities, work with 80 college and university partners, and claim over 6,000 professionals in the workforce as Alumni. To get there, we will rely on the strength of our partnerships, the generosity of our supporters and the firmness of our conviction that diverse teams of driven individuals can accomplish amazing things.



Student profiles at four-year colleges and universities in the United States do not yet reflect the country's changing demographics.




how posse

In 1989, the Posse Program began in response to a troubling pattern. Posse President and Founder Deborah Bial, who at the time had been conducting leadership training in New York City public high schools, noticed that many talented students were leaving the city for college only to return months later having dropped out. At the time, "posse" was a popular term in youth culture used to describe a group of friends who look out for one another, who back each other up. One particular student who had dropped out remarked that if he had his posse with him, he would have stayed and ultimately graduated. It seemed an incredibly simple idea. Why not send a Posse, or a team of students, together to college?







"The 26-hour bus trip to Nashville, Tennessee, was the beginning of a life journey, and I had no idea what to expect. I remember a cover story in the *Nashville Scene* called us an experiment. We knew that a lot was at stake—most of us were the first in our families to go to college—but there were so many unknowns. The reason I was able to succeed was because I had my Posse with me. Vanderbilt and Posse opened doors for me to dream about a future that I never thought possible. It was an experience that allowed me to know deep in my heart that my life's work would be about diversity, leadership and access in higher education."

The concept of a Posse works for both students and college campuses and is rooted in the belief that a small, diverse group of talented students—a Posse—carefully selected and trained, can serve as a catalyst for increased individual and community development. As the United States becomes an increasingly multicultural society, Posse believes that the leaders of this new century should reflect the country's rich demographic mix, and that the key to a promising future for our nation rests on the ability of strong leaders from diverse backgrounds to develop consensus solutions to complex social problems. One of the primary aims of the Posse Program is to train these leaders of tomorrow.

One Posse Scholar told a group gathered to celebrate at Vanderbilt University's 2010 graduation, "You don't understand; I could have gone to my local community college, or I could have gone to Vanderbilt. Those were my two options." She paused and said again, "Those were my two options."

For 20 years, Posse has been finding smart, ambitious, talented students working hard in the urban public high school systems. Posse is helping to make sure that these young people are getting connected to the nation's top colleges and universities, which are often not able to sift through the countless underresourced high schools and the thousands of high school seniors enrolled in them.

In 2009, close to 12,000 students were nominated for the program, and Posse partner colleges and universities awarded a record \$67 million in leadership scholarships to 480 winners.

The tremendous accomplishments of Posse Scholars over the past two decades tell a powerful story of achievement. These young leaders, since the beginning, have surpassed expectations, giving cause for optimism about our country's future. Our Scholars have built a strong reputation for outstanding achievement by starting and leading campus organizations, winning Fulbrights and other fellowships, and graduating at a rate of 90 percent. Posse Alumni are attending graduate schools and steadily climbing the ladders of success in a wide array of professional fields. Over the next decade, today's 1,200 Posse Alumni will grow six times over, and by the year 2020, Posse Scholars will have won close to \$1 billion in leadership scholarships.

The journey to date has been remarkable. The Posse Foundation has developed one of the most comprehensive college access and youth leadership development initiatives in the country and has a wonderful track record of success. Sustaining exponential growth for the past decade, Posse has been able to develop more college and university partnerships, has been able to expand into seven cities and now serves more young people than ever.

In 2010, The Posse Foundation became one of only 10 organizations selected by President Obama to receive a portion of his Nobel Peace Prize Award money. The President's support was a message to the country that these young people are needed as leaders. We were thrilled.

On this 20th anniversary, we especially want to acknowledge Vanderbilt University, which, in 1989, took a chance on a then untested program and gave a group of students from New York City a once-in-a-lifetime opportunity. If it weren't for that leap of faith, the options for the thousands of young people to follow could have been very different. We want to acknowledge Michael Ainslie, who, in 1995, became The Posse Foundation's first board chair and successfully worked to establish a tremendous network of support. Without his belief, experience and love, the organization would not have thrived.

We want to acknowledge the magnanimity of people like Tim Ubben, who not only worked to open Posse Chicago, but, in 2006, contributed \$10 million to Posse's endowment, doubling its value in one fell swoop.

We are fortunate that the story of Posse is one full of generous, insightful and dedicated individuals who—inside their colleges, universities, foundations and companies—saw the potential of an idea and helped to realize it. We thank Posse's dedicated staff and board members—and we thank each and every one of you for playing such a critical role in advancing Posse's mission. Our world is clearly better for it.

RECRUITMENT

From September to December each year, Posse conducts the Dynamic Assessment Process (DAP), a unique evaluation method designed to identify young leaders who might be missed by traditional admissions criteria but who can excel at selective colleges and universities. Using nontraditional forums to evaluate potential, DAP offers students an opportunity to demonstrate their intrinsic leadership abilities, their skill at working in a team setting, and their motivation and desire to succeed. DAP has proven to be an extremely effective tool for identifying outstanding young leaders. Through a three-part process, including large group and individual interviews, Posse staff and university partner administrators ultimately select a diverse group of 10 students for each college or university, thus forming a Posse.

PRE-COLLEGIATE TRAINING PROGRAM

From January to August of their senior year in high school, Posse Scholars meet weekly with staff trainers and their Posse peers for two-hour workshops. The Training Program consists of workshops that address four areas: 1) team building and group support, 2) cross-cultural communication, 3) leadership and becoming an active agent of change on campus and 4) academic excellence. The goal of the Training Program is to prepare Scholars for leadership roles on campus and for the high-level academic expectations of their colleges.



CAMPUS PROGRAM

The Campus Program works to ensure the retention of Posse Scholars and to increase the impact of Posse on campus. Posse staff members visit each university four times a year for meetings with Posse Scholars, campus liaisons and mentors. Each mentor meets weekly with the Posse as a team and with individual Scholars every two weeks during the first two years in college. In addition, Posse facilitates an annual weekend-long PossePlus Retreat attended by members of the larger student body, faculty and administration with the goal of discussing an important campus issue identified by Posse Scholars.





CAREER PROGRAM

The Career Program supports Posse Scholars as they transition from being leaders on campus to becoming leaders in the workforce. Posse plays an integral role in the professional development of these young people by providing them with the tools and opportunities necessary to secure highly competitive and career-enhancing internships and jobs. One of the ways Posse achieves this is by partnering with exceptional companies and organizations, both nationally and abroad. The Career Program has three core components: 1) The Internship Program, 2) Career Counseling Services and 3) The Alumni Network.

POSSE ACCESS

Posse Access is a new online database designed to give Posse partner colleges and universities exclusive access to unselected student nominees to consider for regular admission. Through Posse Access, the hundreds of finalists nationwide who are not selected can opt to have their application profiles made available to each of Posse's partner institutions. By identifying candidates through the Posse Access database, partner schools benefit from Posse's holistic approach to evaluating student potential and see a much greater pool of highly qualified students.







2007 | AINSLIE ALUMNI ACHIEVEMENT AWARD



Since opening in New York City in 1989, Posse has launched six additional sites and recruited more than 3,000 young leaders across the country. Posse's expansion to new cities would not have been possible without grants from the Department of Education Fund for the Improvement of Postsecondary Education (Posse Boston); "the Chicago Seven," a group of generous philanthropists including Tim and Sharon Ubben, Wade and Beverly Fetzer, Christine and Faris Chesley, Sue and John Cole, Robin and John Roberts, Tina and Byron Trott, and Scott and Beth Daley Ullem (Posse Chicago); The Goldman Sachs Foundation (Posse Los Angeles); The Sallie Mae Fund (Posse D.C.); The Arthur M. Blank Family Foundation (Posse Atlanta); and The New World Foundation in partnership with the NoVo Foundation (Posse Miami).

In the next 10 years, Posse will expand to three new cities, partner with 80 universities, support 4,000 Scholars on campus and recruit 1,000 new Scholars annually.





NOTES TO FINANCIAL STATEMENTS

(a) Net Assets

Posse's financial statements have been prepared on the accrual basis of accounting. Posse adheres to accounting principles generally accepted in the United States of America.

(b) Posse maintains its net assets under the following three classess:

Unrestricted: represents resources available for support of Posse's operations over which the Board of Directors (the "Board") has discretionary control.

Temporarily restricted: net assets resulting from contributions and other inflows of assets subject to donor-imposed stipulations that either expire by the passage of time or can be fulfilled and removed by actions of Posse pursuant to those stipulations. When such stipulations end or are fulfilled, such temporarily restricted net assets are reported in the statement of activities as net assets released from restrictions.

Permanently restricted: net assets subject to donor-imposed stipulations that principal be maintained permanently by Posse, but the earnings of which are available and accounted for in unrestricted operations.
